Please find below the response to your recent Freedom of Information request regarding ICT services within NHS Southport and Formby CCG.

Request/Response:

1. ICT Strategy- I require the document that hold future plan and strategy of the organisation's ICT department

NHS Southport and Formby CCG has a strategic partnership with Informatics Merseyside, its IT delivery partner. In conjunction with Informatics Merseyside and other North Mersey Trusts, the CCG has developed the ILINKS Informatics Transformation Strategy, please see link below

It has also developed the Merseyside Digital Roadmap (please see Appendix 1). Both of these form the CCG's IM&T strategy and direction of travel for IM&T over the next few years.

2. ICT Departmental Business Plan

As NHS Southport and Formby CCG has a strategic partnership with Informatics Merseyside, it does not directly employ any IM&T staff and therefore does not have an IM&T departmental plan.

3. ICT Technical Strategy

4. ICT Structure

The CCG does not have an ICT structure as it does not employ any ICT staff directly but has a Service Level Agreement in place with Informatics Merseyside.

5. ICT Capital budgets and programmes
