## Request/Response:

Please provide answers to the questions below including answer for the previous three financial years (2015-16, 2016-17, 2017-18) and any known information (for example, planned spending) for the year 2018-19. If you cannot provide information for the full three-year period, the most recent information you have would be appreciated.

1. Do you employ a mental health lead?

Yes, NHS Southport and Formby CCG has employed a mental health lead since 2014.

- 3. Adult mental health: Acute hospital liaison
  - a. Do you commission A&E and Ward liaison teams to operate 24/7? Are such liaison teams universally included in contracts for the provision of acute hospital services?

Yes, hospital liaison is provided by our secondary mental health provider CORE 24. Funding commenced in September 2017.

- 4. Adult mental health: Crisis and acute care and suicide prevention
  - a. Do you commission a crisis resolution home treatment (CRHT) as an alternative to acute in-patient admission? Does this service operate 24/7?

We commission a "stepped up care" function within Community Mental Health Teams which undertakes aspects of CRHT. This is currently being redesigned to meet CRHT fidelity by 2020/21 in line with the Mental Health 5 Year Forward View.

At present the service is offered: Mon-Fri 08:00-20:00 Sat & Sun 09:00 – 13:00

b. Response times

The assessment service operates to the following response times based on triage, based on the following:-

- Immediate
- Urgent: seen within 72 hours
- 5. Children's and young people's (CYP) mental health
  - a. Do you involve CYP and parents/carers in commissioning and service design for CYP?

We work with a number of groups to inform our commissioning and redesign service. For example Camhelions and Sefton Young Advisors who are a group of young people from Sefton, Merseyside who care about mental health.

b. Do you commission specialist treatment for CYP with eating disorders?

Yes

c. What is the proportion of CYP with eating disorders seen within 1 week (urgent) and 4 weeks (routine)?

In 2017/18 93% of urgent referrals were seen within 1 week and 86% of routine referrals were seen within 4 weeks.

- 6. Perinatal mental health
  - a. Do you commission specialist perinatal mental health services? If so, what was the total amount (£) and total amount spent on perinatal mental health services?

NHS England commission perinatal mental health services for Southport and Formby residents as part of a wider Cheshire and Mersey approach.

A strategy is being developed across the Cheshire and Merseyside footprint as part of our partnership working.

- 7. Mental health of older persons
  - a. Do you commission tailored, community based, physical or other activity programmes for older persons?

Yes, we commission these services from the Alzheimers Society, Sefton Carers Centre, Swan Centre, Expect, Age Concern and the Netherton Feelgood Factory.
