












We are looking at 6 policies for treatments:





Continuous glucose monitoring systems

Continuous glucose monitors (CGM) use a small sensor just under the skin to measure blood sugar levels every few minutes. A display device shows what the level is. Diabetic patients need to watch their blood sugar levels carefully.

We suggest this is offered to patients unable to recognise or communicate about their symptoms of hypoglycaemia, because other methods would not be appropriate. The patient must commit to use it at least 70% of the time. Additional criteria will also ensure pregnant patients and children with diabetes will receive CGM where appropriate.

Cough assisted devices remove mucus from the lungs. They help patients who can't cough well enough on their own.

We suggest this will only be given to patients who have a weak cough or can't cough well enough. We will use tests to measure the strength of their cough and their lungs.



Insulin pumps are worn outside the body and can be programmed to continuously pump insulin into the body. Diabetic patients use insulin to control their blood sugar levels.

We suggest only giving these to patients who have already tried controlling their diabetes with daily injections but regularly have severe high or low sugar levels.

Prostatism or lower urinary tract infections can affect your bladder, urethra or kidneys. Most can be treated with antibiotics. Surgery can be an option to destroy part of the prostate.

We suggest we will only pay for surgery if the patient has severe voiding (emptying) or storage (retention) problems, and if all other options have failed or are not suitable.

Joint injections are where steroids (manmade hormones) are injected into areas like shoulders and knees. They help patients who have stiff, swollen or painful joints. Secondary care means by a specialist and/or in a hospital.

We suggest this will only be done in secondary care if a GP can't do it or if they need an ultrasound to see where to give the injection.



Transanal irrigation – new Merseyside policy

Transanal irrigation involves flushing faeces (poo) from the bowel (rectum and colon) with water. It helps patients who have conditions like bowel incontinence or constipation.

We suggest we only give this to patients who have tried all other options and has had all the tests and scans. The patient must commit to use it on alternate days.






